- Dancing will be run in accordance with the SOBHD rules and regulations.
- Age Group divisions will be determined after entries are received
- All dancers must be in appropriate costumes to receive awards
- Current FUSTA (2010) registration number needs to accompany completed entry forms.
- Current FUSTA (2010) card is required to be able to compete
- Any competitor not present when event is called will forfeit that dance
- Judges decision is FINAL
- Any complaints must be submitted in writing with a \$10 fee to the Wyoming Highlanders Scottish Association
- Competitors must pay the entry fee of \$21.00 (check or money order), which entitles them to full entry onto the field.
- Primary and Beginner Dancers not doing all 4 dances will be \$5 per dance. Please add \$1.00 to the total for FUSTA fees
- **Advance registration is necessary** Dancers entering after August 7th, 2010 will be considered late and a \$10 late fee will be assessed
- Registration check-in at 8:00-8.45 AM. Dancing begins at 9:00 AM with the Highland Fling (All Classes)
